

**THE SITEONE LESCO® 60<sup>TH</sup> ANNIVERSARY SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

**ELIGIBILITY:** The SiteOne LESCO® 60<sup>th</sup> Anniversary Sweepstakes (the "Sweepstakes") is not open to the general public and is only open to eligible businesses. Sweepstakes entries may only be submitted by individuals (each, an "Entrant") who are a) legal residents of the 50 United States (excluding Alaska) or the District of Columbia (D.C.); b) age 18 or older and the age of majority in their state of residence (19 in Alabama and Nebraska; 21 in Mississippi); and c) currently employed by or own a commercial landscape business ("Eligible Business"). Sponsor reserves the right to verify eligibility requirements. Void in Alaska, Puerto Rico, all other U.S. Territories and Possessions, outside the U.S./D.C. and where prohibited by law. Employees of SiteOne Landscape Supply, Inc. **HOW TO ENTER:** There are two (2) ways to enter.

**Grand Prize, First Prize and Second Prize winners:** The potential Grand Prize winner, First Prize winners and Second Prize winners will be notified by the Sweepstakes Administrator at the email address or phone number associated with the Eligible Business's SiteOne Landscape account, or as provided if such Eligible Business entered via Mail-In Entry. to show proof of Eligible Business ownership to Sponsor's satisfaction. Noncompliance will result in disqualification and an alternate winner may be selected.

**DISPUTES:** The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Fulton County, Georgia and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Fulton County, Georgia. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another

party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Fulton County, Georgia. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.
